

Result area 2 - Preventing violence against women Women's Rights and Gender Equality

RESULTS

There has been improvement in the accessing and delivery of justice on sexual violence cases by the courts. Sexual violence cases are now being handled more expeditiously, reduced adjournments of cases and coordinated processes between the prosecutors and investigating officers on production of evidence and securing of witnesses. 226 women were trained as TOTs on policy advocacy and budget tracking in Meru county. Women trained as Trainer of Trainers on policy have demonstrated prosecutions and investigating of interesting and security of the state of the stat

In Meru county for instance, out of the 19 women led groups supported by CREAW, 9 were CBOs comprising of an average of 12 grassroots women led groups. In their monthly meetings besides discussion on their livelihoods and economic In there country for installines, out of the TOTs used the formus to share the knowledge gained from the workshops on policy advocacy, county budget making and planning processes, sensitization on the available laws on ending GBV and movement building skills in carrying out accountability on the public authorities in the implementation of legal frameworks at the county level.

As a result, in Meru County, the TOTs reached the total group membership on 2,360 women in 19 women led groups and CBOs. (9 CBOs/12 groups/20 members= 2,160 women) plus (10 groups/20 members=200).

In Istiffic County, CREAW worked with a network of women led groups comprising of 14 grassroots women groups of 20 members each on average totaling to 280 women in the groups reached by the trained TOTs.

The project prioritized on enhancing the capacity of 20 existing and 2 new Disabled People Organisations (DPOs).20 organizational capacity assessment (OCA) of 20 DPOs were conducted who developed institutional development plans to enhance their management skills and practices with 1842 Women with a Disability (WWD) to join existing groups or form new DPOs. Promotion of Economic empowerment for women, and People with a Disability (PWD) groups through provision of funds for micro-saving ventures for the women groups and enterprise development (20 grants issued to 20 women DPOs. With the allocated funds, the women accountability groups this is geared towards social, economic empowerment of grassroots women in the counties
